	CATEGORIES	DESCRIPTION
#1	Miss. Beach&Sarong Wear	This category invites contestants to unveiling the cultural significance of the sarongs and allow them to appreciate not just the garment itself, but also the rich cultures and traditions it represents. Contestants will be evaluated on their confidence, creativity, and their reflection of the islanders close relationship with nature, representing the islanders respect and appreciation for their surrounding environment.
#2	Miss. Talent	The Miss Talent category gives the contestants a unique opportunity to Showcase her skills she have and her ability to take something ordinary and make it extraordinary. Each contestant will perform a talent of their choice 3 minutes for singing, 5 minutes for talents which may include dancing, acting, or any other artistic expression. Contestants will be judged on originality, execution, stage presence, and overall impact of their performance. This category celebrates individuality and the diverse talents that each contestant brings to the stage.
#3	Miss Culture Attire	In the Miss Culture Attire Category, contestants are encouraged to showcase traditional or culturally significant attire that reflects their heritage. This is an opportunity to celebrate diversity and heritage through fashion. Contestants should be prepared to explain the significance of their chosen attire to the judges during the presentation.
#4	Miss Evening Gown	The Miss Evening Gown category allows contestants to display elegance and poise in formal attire. Contestant will be judged on their overall presentation, including the style and fit of their gown, confidence, and stage presence. This category emphasizes grace and sophistication as contestants walk the runway.
#5	Interview/Question	The Miss interview category assesses contestants communication skills, confidence and ability to articulate their thoughts on a variety of topics. Contestants will participate in a structured interview with the judges, who will ask questions related to personal experiences., current events, and the contestants platform or goals. This category emphasizes poise under pressure and the importance of being well-informed and articulate,. Scores will be based on clarity, confidence, and the depth of responses.
#6	Miss Congeniality	The Miss Congeniality award recognizes the contestant who best exemplify kindness, support, and camaraderie among their peers. Contestants will be voted on by their fellow participants, highlighting the importance of teamwork and friendship throughout the competition. Additionally, this year the contestant who sells the most tickets for the pageant will also be awarded Miss Congeniality.

#7	Miss Photogenic	In the Miss Photogenic category, each contestant must submit 3 of their best photos. It is recommended to show different angles of headshots and full-body images. These photos may be Business, Professional, and everyday natural photogenic and glamour photogenic, At least 5x7 but no larger than 8x10, color, no frame, no crowns or banners, these photos will be judged and looked at by our judges, judges will be looking at personality, beauty, grooming fashion sense and confidence.
#8	Miss Internet	The contestants is required to send the Pageant Director her official photo of which she want to post on the Miss Alaska Pacific Island Pageant Facebook Page. The winner will be determined by the total number of likes and shares their photos received. Results will be announced during the event.
